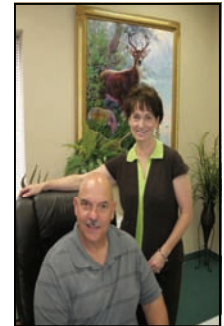

Temps Take Charge!

The novelty of temporary employees in the workplace has worn off. Nearly all offices have had their share of "temps". That doesn't mean the days of hiring short-term employees are over; just the opposite.

Temps are everywhere, and the number is growing.



U.S. staffing firms employed an average of 3.06 million temporary and contract workers per day in the fourth quarter of 2007.

Temporary help sales in the fourth quarter totaled \$18.7 billion, 0.7% more than the same period last year.
